





1. The Company is a Core Investment Company, which earns income through dividends, interest and gains on investments held. Hence, the Company's business activity falls within a single business segment accordingly there are no reportable segments.

2. Previous period's figures have been regrouped/reclassified wherever necessary to conform to the classification for the current periods.

3. CFL Capital Financial Services Limited ('CFL') in which the Company holds more than 20% of the equity has not been considered for consolidation. Accordingly, we are unable to comment on the consequent impact on the holding company's consolidated results.

Management remarks: - Since the Company does not have any significant influence over the affairs of CFL, it is not considered as an associate company for the purpose of consolidation under Sec. 129(3) of the Companies Act, 2013.


4. The figures for the quarter ended March 31, 2022 and March 31, 2021 are the balancing figures between audited figures in respect of the full financial year up to March 31, 2022 and March 31, 2021 respectively and the unaudited published year to date figures up to December 31, 2021, being the date of the end of the third quarter of the respective financial years, which were subject to limited review. Further, consolidated figures of corresponding quarter ended March 31, 2022 as reported in these results have been compiled by the management in accordance with Ind AS which has been subjected to audit /review.

5. The above audited financial results of the Company for the year ended March 31, 2022 have been reviewed by the Audit Committee and thereafter approved by the Board of Directors at their respective meetings held on May 24, 2022. The statutory auditors of the Company have carried out the audit of the aforesaid results.

6. The Covid-19 pandemic has affected several countries across the world including India. The pandemic and consequent lockdown imposed by the government authorities has considerably impacted the business operations of our investee companies which impact our financial results. Hence figures for corresponding previous period is not comparable with the figures for the year ended March 31, 2022. The Company has considered the possible effects that may result from the COVID-19 pandemic in the preparation of these financial results including the recoverability of the carrying value of financial and non-financial assets. In developing the assumptions relating to the possible future uncertainties in the global economic conditions because of COVID-19, the Company has, at the date of approval of these financial results, used internal and external sources of information and expects that the carrying value of the assets will be recovered. Given the dynamic and evolving nature of the pandemic, these estimates are subject to uncertainty and may be affected by the severity, duration of the pandemic and other variables.
